PARK ADDITIONS

The Commissioners' Court of Winkler County, Texas is accepting bids to construct a Children's Spray Park with toys, swimming pool and Clubhouse which will include dressing rooms & showers. Sealed bids will be received until 10:00 a.m., March 22, 2010, at which time bids will be opened in Commissioners' Court. Bids received after this time will be returned to bidder unopened.

Bids must be submitted in a sealed, opaque envelope which is marked on the face Winkler County Parks Project. Bids may be mailed to Winkler County, c/o County Auditor, Drawer O, Kermit, Texas 79745, or may be hand delivered to the office of the Winkler County Auditor, 1<sup>st</sup> Floor Courthouse, Kermit, Texas 79745.

The bid price for the park additions should include both Wink & Kermit locations. Bidder shall include the terms of any warranty with the bid price.

Specifications for the Park Additions are as follows:

Both facilities must meet Texas Disability Standards, Texas State Health Department Standards, and Texas Parks & Wildlife Standards with inspections. All contractors must provide 3 references of similar projects. This project will be considered a turnkey project.

The Commissioners' Court reserves the right to reject any or all bids and to waive any irregularities or informalities in any bid received.
