

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$ 0.275597 per \$100 valuation has been proposed by the governing body of the City of Wink.

PROPOSED TAX RATE	<u>\$0.275597</u>	per \$100
NO-NEW-REVENUE TAX RATE	<u>\$ 0.275597</u>	per \$100
VOTER-APPROVAL TAX RATE	<u>\$ 0.286509</u>	per \$100

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for the City of Wink from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that the City of Wink may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that the City of Wink is not proposing to increase property taxes for the 2020 tax year.

A PUBLIC MEETING ON THE PROPOSED TAX RATE WILL BE HELD ON AUGUST 31, 2020, 6:00 P.M. AT THE CITY OF WINK, 303 E. HENDRICKS BLVD, WINK, TX.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, the City of Wink is not required to hold an election to seek voter approval of the rate.

However, you may express your support for or opposition to the proposed tax rate by contacting the City Council Members of the City of Wink at their offices or by attending the public meeting mentioned above.

Your taxes owed under any of the tax rates mentioned above can be calculated as follows:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by the City of Wink last year to the taxes proposed to be imposed on the average residence homestead by the City of Wink this year.

Tax on average homestead	124.66	131.78	Increase of \$7.12, or 5.40%
Total tax levy on all properties	94,229.10	100,590.21	Increase of \$6,361.11, or 6.32%
